NCAA MEN'S BASKETBALL OFFICIATING REGIONAL ADVISOR JOB DESCRIPTION

The NCAA shall select two (2) Regional Advisors to the National Coordinator of Men's Basketball Officials ("Regional Advisor") via an independent contractor services agreement to support the coordination of its men's basketball officiating program and evaluation of Division I men's basketball officials. The Regional Advisor shall assist the National Coordinator to further the NCAA's ongoing commitment to improving the overall quality and consistency of officiating throughout collegiate men's basketball. Additionally, the Regional Advisor will assist the National Coordinator and support the NCAA Division I Men's Basketball Committee in the identification, training, selection and evaluation of officials for the Division I Championship.

The Regional Advisor's duties and responsibilities include, but are not necessarily limited to the following:

- Monitor and evaluate officials to ensure proper application of the points of emphasis as defined by the NCAA Men's Basketball Rules Committee.
- Serve in a consultative capacity to the national coordinator of officiating in connection with the selection, assignment and advancement of game officials during the Division I Men's Basketball Championship as well as other officiating matters.
- Attend a regional officiating clinic where the National Coordinator will present to the
 Division I, II and III conference coordinators of officials, outlining the new rules, points-ofemphasis, mechanics and other officiating matters. Throughout the season, work regularly
 with the National Coordinator and Division I conference coordinators of officials, as
 appropriate, to assure the most consistent and effective teaching and communication is being
 utilized in developing the available "pool" of officials.
- Evaluate regular-season game video and send suggestions to the National Coordinator for the development and enhancement and maintenance of the NCAA officiating website.
- Maintain a heightened degree of diligence and awareness regarding any semblance of gambling influence, by or among officials, whether real or perceived, at all times.
- Participate in the in-season teleconferences with the conference coordinators of officials and participate in teleconferences with the National Coordinator.
- Attend the coordinators of officials meeting in September each year and attend at least one regional officiating clinic each fall.
- Responsible for miscellaneous projects as assigned by the National Coordinator.
